The art of good conference production

The art of good conference production relies upon relevant content, engaging speakers, first class facilities and ensuring the event not only educates and informs the audience but provides value for money.

Beyond that, it should offer great networking and be an enjoyable experience for all involved.

The profusion of video conference events during the Covid-19 pandemic has provided some innovation but often the technology is not used to its best and audience attention and engagement is poor with reduced networking success.

There have been very few in-person events in recent years dedicated to health insurance as a health system financing tool. We are changing that.

Our format

In 2018 we believed that a new format was required to bring alive health insurance conferences and make them relevant to a wider audience. We believe that smaller, more intimate events offer greater, more valuable networking and knowledge transfer opportunities. We saw this format succeed at a number of events in Europe during 2017 and 2018.

Our events have been changing the *status quo* of in-person events which are re-emerging in many parts of the world as travel restrictions constantly change.

Whilst the themes should be relevant to the broader region, speakers should have global experience to bring insights from other parts of the world.

Our events are "quality" not "quantity" events. Importantly, they are "how to do" not "what to do" events.

Our events so far

Since 2018 and despite the pandemic, we have produced events in UAE, Kenya, Ghana, Rwanda, Bahrain, South Africa, Singapore and Panama. This West Africa event will be our 13th event in total, our 7th in sub-Saharan Africa and our 2nd West Africa event.

Why Nigeria?

The passage of the National Health Insurance Act in Nigeria in 2022 brings new opportunities for all in the health insurance ecosystem but also challenges. Although one of the most populous countries in Africa, the previous NHI scheme failed to reach more than a small proportion of the population.

Neighbouring countries in West Africa are also at different stages of development of their health systems and much can be learnt from an exchange of ideas and solutions to extend the reach of Universal Health Coverage.

The themes

Innovation in both technology and products are important to the sustainability of any financing system, public or private. This event will highlight the Power of African innovation in these two areas. Yet just as important are partnerships between public and private sectors and between different private sectors such as banks, telcos and insurers.

A different calibre of speaker

Several of our speakers will have experience of speaking at conferences around the globe and will generally be high level executives who can bring their globally acquired experience to our audience.

But we can equally learn from regional speakers who have experience of their own markets which have different challenges. The opportunity for knowledge transfer between speakers from outside the region and within the region is enormous.

The audience

We expect the forum to be attended by insurers and reinsurers, intermediaries, regulators, IT firms, financiers, telcos, pharmacos and healthcare providers.



Lagos State Health Management Agency Nigeria Dr. Emmanuella Zamba is a Medical Doctor and a Public Servant. A public health expert and a health systems strengthening specialist. She has vast experience in Healthcare Planning, Health Financing, Human Resource for Health, Quality and Healthcare Management.

She is currently the Permanent Secretary, Lagos State Health Management Agency (LASHMA), the Agency responsible for ensuring that all Lagos residents have access to affordable and qualitative healthcare and also responsible for regulating and sanitizing the health insurance space in Lagos State.

On assumption of her position in LASHMA, she championed the establishment of Ekotelemed as the first state owned Telemedicine platform in the country which is the backbone of the state Covid response and it is being offered as a stand-alone plan for all residents of the state. The Agency is currently deploying Virtual Booths across the state to deepen access to healthcare. Dr Zamba has developed and implemented numerous initiatives geared towards the success of the Lagos State Health Scheme (LSHS) such as, Rebranding the scheme for relatability to the informal sector; Development of additional health plans most especially the Diaspora Plan; Expanding grassroot presence through the deployment of divisional and sub divisional offices, Creation of employment opportunities and a career path in the state health insurance industry with respect to Sales, Marketing, Business Development and Quality Assurance/Improvement. Under her leadership, the scheme has witnessed significant growth of about 5,600% increase since her resumption of duty and won the best State Health Insurance scheme in Nigeria for 2023.

The Agency was able to commence its regulatory functions and start the implementation of the service charter to enhance quality healthcare delivery. She has also birthed the Eko Social Health Alliance which is responsible for the mobilization of funds for the vulnerable members of the state and ensuring they are enrolled under the Lagos State Health Scheme. She led the Agency to host the first ever Lagos State Health Insurance Summit and the Agency

She is fondly called the Health Service Charter champion and she cascaded the service charter to all secondary facilities in the state. She has received four (4) different awards for service charter between 2015 till date.

Dr Zamba operates an open door policy, she enjoys mentoring and she has a deep and abiding passion for social welfare. She considers Innovation, Strategic Planning and Adaptability key tools for progress and is a strong advocate for transparency and accountability.




