1 Applicability

The International Health Insurance Forum (hereinafter referred to as “IHIF” or by use of the words “we”, “us” “our”) is a brand of The Consilient Consultancy Limited which is a company registered in Ireland with company number 668369 (hereinafter referred to as “Consilient” or by use of the words “we”, “us” “our”). The name “Consilient” and the acronym “IHIF” can be interpreted interchangeably in this document. Consilient provides its services to you subject to these terms and conditions of use. In the case where payment does not clear, Consilient has a right to cancel the order completely.

13 Right to cancel and refunds
